## 4. Provincial Updates:

Since the provincial election has been called, the government will be in 'care-taker' mode until after October 24. Plans are underway to proceed with the initiative to hire and train additional health care support workers.

A collaborative approach across sectors is underway to develop and launch the health care support worker learning pathway.

### 5. Question & Answer Session (grouped by topic):

Personal Protective Equipment (PPE)

Q: Can we provide our own medical grade googles for our students and faculty members as not all units are providing these?

A: Health organizations are responsible to provide PPE for clinical placements. Please contact student education leads for follow-up with the site/unit and to confirm that a plan is in place.

Q: A small number of our students are using N95s for ambulance placements. Are we ok to continue fit testing every two years to conserve our supply of N95s?

A: Yes.

Q: Are we to follow the PEG's where the mask fit test is annually or can we use the HA guidelines of every 2 years?

A: Health care organizations (HCOs) follow the Ministry of Health Policy Communique May 19, 2020 which states:

- Health authorities facing an imminent shortage of N95 respirators shall allow workers who
  have had their respirator fit test within the previous 2 years continue to use respirators
  without additional testing.
- Health authorities facing an imminent shortage of N95 respirators shall ensure these same
  workers perform a fit check or seal check prior to the use of the respirator, and where that
  check reveals an issue with the seal, a full fit test will be performed.
- Health authorities not facing an imminent shortage of N95 respirators shall perform annual fit tests as required by section 8.40(2.1) of the Occupational Health and Safety Regulation.

## **Practice Setting**

Q: What is each HA's policy on student nurses completing flu immunization on minors? Is there a certain age "cut off"?

A: Announcements on this year's flu campaign and approach will be forthcoming soon and widely distributed.

Q: Can nursing students complete COVID swabbing in the hospital setting? We are adding this to our curriculum.

A: Kathy Scarborough reported that FHA is expanding their testing sites and want to have nursing students in those settings. Please follow-up with Student Practice at FHA to find out more information regarding the destinations in HSPnet.

Q: Are students in UBC health programs still not seeing COVID presumed/positive pts?

A: Nick Steel confirmed that UBC Health students are not providing care to COVID patients at this time. If you would like more information, please contact Nick at <a href="mailto:nick.steel@ubc.ca">nick.steel@ubc.ca</a>.
