First Nations Education Steering Committee (FNESC)

Lead policy and advocacy body on First Nations education (ECE, K-12 and PSE) in BC

Indigenous Adult and Higher Learning Association (IAHLA)

Represents ~44 Indigenous post-secondary and training Institutes

Alliance of BC Modern Treaty Nations

Represents 8 First Nations who have negotiated modern treaties with BC and Canada

VP Standing Committee on Indigenous Health

Provides system-wide and regionally appropriate strategic direction and guidance to improve Indigenous patient and family experiences, quality of care, and outcomes of care for Indigenous peoples in BC

Métis Nation BC (MNBC)

Represents the Métis Nation in BC, divided into 39 Métis Chartered Communities

First Nations Health Authority (FNHA)

Health and wellness partner to over 200 diverse First Nations communities and citizens across BC

Regional HA VPs of Indigenous Health

Provides strategic direction and guidance to regional HAs to improve Indigenous patient and family experiences, quality of care, and outcomes of care for Indigenous peoples in BC

BC Aboriginal Training Employment Alliance Members (BCATEAM)

Represents 14 First Nation ISETS partners

Indigenous Skills and Employment Training Strategy (ISETS) Partners

24 agreement holders in BC including First Nations, Métis Nation BC and urban Indigenous organizations funded by Canada to provide skills and employment training
