

## Violence Prevention Training for Students on placement at BC Health Authorities

All students, like health employees, are required to take Provincial Violence Prevention training to meet the requirements at the site of their practice experience/practicum, based on the provincial OH&S requirements, **attached** which designates risk levels (low/medium/high) and training requirements.

# Provincial Requirements for Violence Prevention Training

## Statement of Intent

All workers are required to take Provincial Violence Prevention Curriculum (PVPC) training relative to the designated or assessed requirements at their workplace. The Violence Prevention Training Matrix has been developed as a communication guide for managers and workers to show the violence prevention training each worker is required to complete.

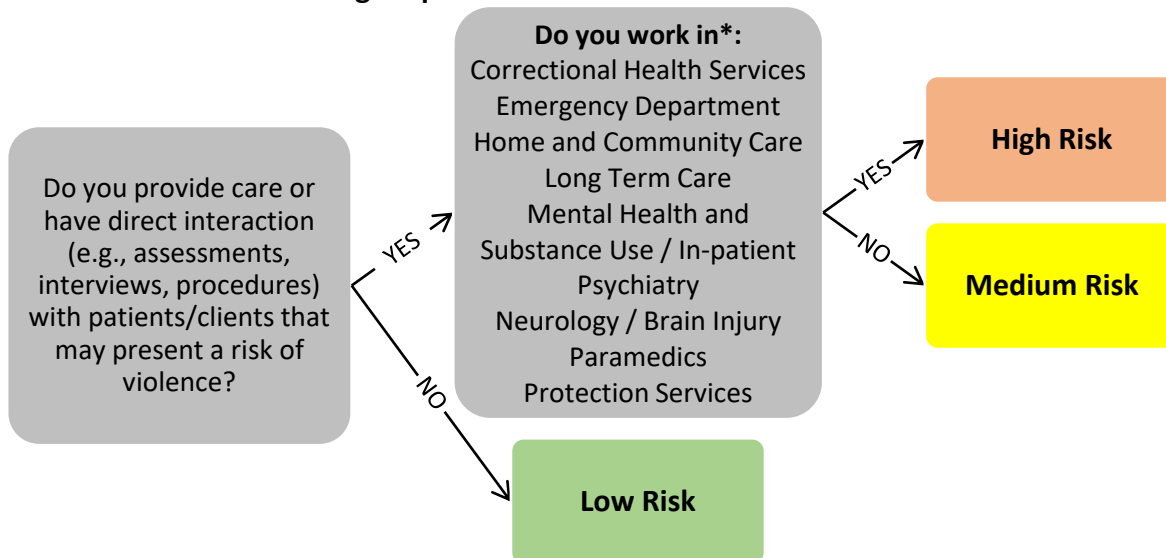
## Information on training requirements:

- **These are the minimum requirements.**
- Every direct care provider is either Medium or High Risk.
- Departments automatically designated as High Risk are listed below.
- Supervisors/managers/clinical educators must have equivalent training as the workers with the highest requirements they supervise and/or support.
- For those workers that are part of a response team for aggressive incidents at their site, contact your Health & Safety Department for information on additional training requirements.
  - Response team training requirements will be part of upcoming provincial standard work. Details will be added to this document as they become available.

## Guidelines for Determining Training Requirements

- Training requirements cannot be reduced below the level designated in the decision flow chart below.
- Training requirements can be increased based on information from action items from a Violence Risk Assessment or the decision of Health Authority leadership based on patient/client population.
- If local teams or Health Authorities wish to exceed these requirements (e.g., move an individual worker or group from a lower level to a higher one), they are able to, as defined by individuals in departments or entire departments that are exposed to higher-than-typical risks.
